Teaser	If you want to shoot with a firearm that requires or does not require a permit, you usually have to apply for a permit beforehand.
Volltext	Firearms are used for various purposes, such as attack, defense, signaling, hunting, long-distance injection, marking, sport or play. If you want to use a firearm, you must first obtain a permit from the relevant authority. You can apply for this permit either for a single shot or permanently.
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Identity card or passport (copy) • Gun ownership card or hunting license <ul style="list-style-type: none"> • For example, an order from an enclosure operator, • Work as a wine/fruit grower • Registration as a veterinarian • Proof of a need • Proof of liability insurance in the amount of 1 million euros (flat rate for personal injury and property damage)
Voraussetzungen	<ul style="list-style-type: none"> • You have a valid permit to purchase and own a weapon (for example a hunting license or firearm ownership card). • You are at least 18 years old <ul style="list-style-type: none"> • want to shoot animals in an enclosure for meat production; • are a fruit or wine grower or run a fish farm and want to drive away birds; • are a veterinarian. • You have a plausible reason for shooting. A plausible reason can be if you <ul style="list-style-type: none"> • They are reliable under firearms law • You are personally suitable • You have taken out liability insurance that covers personal injury and property damage up to a flat rate of 1 million euros. • You have lived in Germany within the last 5 years

Hinweise	<ul style="list-style-type: none"> • want to shoot in a shooting range, for example at your shooting club; • as a hunter, you wish to shoot during authorized hunting or you wish to shoot animals that are subject to nature conservation law and have the appropriate permission from the nature conservation authority; • as a traditional marksman, you wish to shoot at an event at which it is customary to carry weapons for special occasions and the head of the traditional marksmen's association has been granted a valid exemption permit in accordance with Section 16 Paragraph 3 of the Weapons Act; • want to shoot with a long gun at shooting ranges at an approved sporting event, for example a biathlon competition; • Weapons that can only fire cartridge ammunition, intended for use during a theatrical performance or similar, or to scare away pest birds; • want to shoot with compressed air, spring-loaded weapons and CO2 weapons with less than 7.5 joules, which are marked with an "F" symbol, with the consent of the owner of the property rights in a fenced area, for example for paintball activities; • at sporting events, on behalf of the organisers, wish to use blank-firing weapons or signal weapons to signal the start or beginning of a competition, provided that such signalling is required; • Fire signal weapons during emergency and rescue exercises if this is part of the exercise.

Sachverhalt

- Your PersonalNWR-ID (P- or F-NWR-ID) for your personal information
 - the permit NWR-ID for the firearms permit (E-NWR-ID)
 - the weapon or weapon part NWR ID (W or T NWR ID)
 - if you have been legally sentenced to a prison term of at least 1 year within the last 10 years and have been a member of or supported a banned organisation within the last 10 years.
 - if it can be assumed that you will misuse or handle weapons or ammunition improperly, fail to store these items carefully or leave them with persons who are not authorized to do so.
 - if you have been in preventive police custody with judicial authorisation more than once in the last five years due to violent behaviour.
 - if you have repeatedly or seriously violated firearms laws.
 - You are legally incapable.
 - You are addicted to alcohol or other intoxicating substances, mentally ill or demented.
 - You suffer from serious illnesses, such as brain injuries, or physical impairments, such as amputations or severe visual impairment.
 - it can be assumed that you will not handle weapons or ammunition carefully or properly, or that you will not be able to store these items carefully, or that there is a concrete risk that you will endanger others or yourself.
- You do not need a permit to shoot a weapon if you
