If you have already submitted this information to the competent authority as part of an authorisation or notification procedure, you do not have to separately notify the construction of the operating area relevant to the incident.

Verfahrensablauf	You submit the complete notification in writing to the authority responsible for you. The responsible authority will examine your report. If necessary, the responsible authority will request further documents or information from you. If an administrative offence has been committed, the competent authority decides whether to initiate administrative offence proceedings.
Bearbeitungsdauer	There is no statutory processing time.
Frist	You must submit the notification to the competent authority at least one month before the start of construction of the operating area.

Hinweise	You are committing an administrative offence if you do not report the start of the construction of an operating area in accordance with the Major Accident Ordinance, or if you do not report it correctly, completely, in the prescribed manner or on time.
