As a result of the admission, you as a member of this group of people can be granted a residence permit or settlement permit. You must apply for the residence permit or settlement permit at the responsible authority.

In Hamburg, the application can be submitted online. • The responsible authority will examine your application and, if necessary, request any necessary documents or information from you. • The responsible office will contact you to arrange an appointment. • If your application is approved, your fingerprints will be taken to produce a new electronic residence permit (eAT card). • You pay the applicable fees. • The Federal Printing Office will be commissioned to produce your new eAT card. • Once completed, you will receive information and can collect the residence permit in the form of the eAT card in person. • If your application is rejected, you will receive a rejection letter. In this case, you will also have to pay an administration fee.
Bearbeitungsdauer	You should expect processing to take 6-8 weeks. If you submit all the required documents in full and well prepared, processing may be quicker. After approval, it will then take another 4-6 weeks for the Federal Printing Office to produce your electronic residence permit.
Frist	The deadlines that apply to you are stated in your acceptance letter.
