Verfahrensablauf	• You submit the necessary documents to the responsible authority. • The responsible authority will check your documents and, if necessary, request further information or documents. • The competent authority grants or rejects recognition. You can have a specialist knowledge course recognized at:
Bearbeitungsdauer	Processing usually takes a few weeks. However, the actual time required depends primarily on the quality of the documents submitted and any additional requests for documents that may be necessary for the application to be examined.
Frist	There are no deadlines for submitting an application.
