Teaser	If you have a firearm ownership card (WBK) or a hunting license and want to purchase a firearm that requires a permit, you must apply for this.
Volltext	<p>If you have a firearms ownership card (WBK) or a hunting license and intend to purchase a firearm that requires a permit, you must apply for this in advance. The so-called pre-entry is a provisional authorization or permit that allows you to purchase a firearm that requires a permit within a certain period of time. A pre-entry is necessary:</p> <ul style="list-style-type: none"> <li>• for the purchase of a multi-shot handgun by hunters or sports shooters</li> <li>• for the purchase of a semi-automatic long gun by sports shooters</li> <li>• for the acquisition of a signal weapon by ship owners</li> </ul>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• Identity card</li> <li>• Gun ownership card or sports shooting certificate or</li> </ul>

	<p>valid hunting license</p> <ul style="list-style-type: none"> <li>• Proof of safe storage</li> </ul> <p>If necessary, additionally for hunters:</p> <ul style="list-style-type: none"> <li>• Proof of 1st and 2nd multi-shot handgun (pistol, revolver)</li> </ul> <p>If applicable, additionally for sports shooters:</p> <ul style="list-style-type: none"> <li>• Proof of expertise</li> <li>• Justification for the need to purchase if more than 2 multi-shot handguns or 3 semi-automatic long guns are already in possession</li> </ul> <p>If applicable, additionally for ship owners:</p> <ul style="list-style-type: none"> <li>• Proof that you own a seaworthy boat</li> <li>• Proof of safe storage on board (Hamburger Kasten)</li> </ul>
Voraussetzungen	<ul style="list-style-type: none"> <li>• You must prove that you can store the weapon safely (gun safe with resistance level 0 or I)</li> </ul>
Kosten	There is an administration fee. The amount of the fee depends on the type and scope of your application.
Verfahrensablauf	<ul style="list-style-type: none"> <li>• You submit your application together with the necessary documents.</li> <li>• The responsible authority will examine your application and, if necessary, request any missing documents from you.</li> <li>• The decision of the competent authority will be communicated to you.</li> </ul>
Bearbeitungsdauer	Up to several weeks
Frist	With the pre-registration you have one year to purchase the weapon that requires a permit.
weiterführende Informationen	
Hinweise	During the application process, it is sufficient to state the type and caliber of the weapon. Detailed information such as manufacturer and model are not required initially. You only have to provide this information when you report the purchase to the relevant authority. The gun dealer is also obliged to report the purchase of the weapon.

	<p>For the preliminary entry, your reliability under firearms law, personal suitability and expertise will not be checked again.</p> <p>Purchasing a weapon without a prior record is a criminal offense.</p>
