This allows you to help shape the goals and measures in the funding area. If an impact is identified, public interest groups will be asked by the competent authority to submit a statement. The results of the participation will be appropriately incorporated into the integrated urban development concept.</p>

The announcement will tell you which communication channels you can use to participate. 	<p>interest group, you will be asked to submit a statement online if you are found to be affected. The statements received will be examined by the responsible authority after the deadline. The municipal council will then weigh up the statements and decide on them. Other private and public interests will be taken into account. The result of the consideration will be communicated to you</p>
Bearbeitungsdauer	: The duration of the procedure is variable and depends on the volume of comments received.
Frist	You can participate for at least 30 days after the public announcement. As an authority or other body responsible for public interests, you must submit your opinion within 30 days of the request.
