The aptitude test is carried out by a privately run foreign placement agency or the central adoption agency of the state youth welfare office.</p>

	<p>After a positive assessment of suitability by the privately run foreign placement agency or the central placement agency of the state youth welfare office, the adoption application is sent to the responsible agency in the child's home country.</p>
