Volltext	<p>The SMC-B (Security Module Card Type B) is an electronic institution card and electronic institution ID card in one. It allows people working in the healthcare professions of an institution to access the telematics infrastructure (TI). The TI connects everyone involved in the healthcare system and will thus enable access to the electronic patient file (ePA) in the future, for example. There are different SMC-Bs for different professional groups. There is an SMC-B for Medical practices, dental practices and psychotherapy practices Nursing, obstetric and physiotherapy facilities Pharmacies With this online service you can apply for an extension of the SMC-B for institutions with employees who are not organized in chambers. These are: Health, nursing and elderly care facilities Obstetric facilities Physiotherapy facilities To extend the SMC-B, you must first reapply for the right to use the card at the electronic health professions register (eGBR). You then apply for the SMC-B at a trust service provider (TSP). The TSP charges an annual fee that varies from provider to provider.</p>
