Teaser	If you want to re-use a grave before the end of the rest period, you must apply for an exemption.
Volltext	The rest period describes the period during which a grave may not be reused. This period is at least 25 years. The rest period begins on the day of the burial and in Hamburg is 25 years regardless of the type of burial. If you want to reuse a grave before the end of the rest period, you must apply for an exemption from the responsible authority.
Erforderliche Unterlagen	The procedure varies between the individual cemetery administrations. Therefore, different documents are required depending on the responsible authority. You should therefore contact the responsible authority before submitting your application and ask which documents are required in your specific case.

Voraussetzungen	The procedure varies between individual cemetery administrations. Therefore, different requirements apply depending on the cemetery. You should therefore contact the responsible authority before submitting an application and ask which requirements must be met in your specific case.

Verfahrensablauf	You submit your application together with any necessary documents to the responsible authority. The responsible authority will examine your application and, if necessary, request any missing documents or information from you. The responsible authority will inform you of the decision on your application.
