Volltext	<p>Compulsory schooling can be fulfilled by attending a state-recognized or state-approved alternative school (independent school, private school). Registration and schooling at the privately run school take place within the framework of a private contractual relationship concluded between the legal guardians and the (private) school authority. Registration and admission to class 1 or 5 of a privately run school takes place directly at the respective school. In the case of a change from a state to a private school, any requirements of the authorities that relate to a decision/approval by the authorities must be taken into account. Admission to a private school is generally in the same grade level that would also be attended at a state school.</p>
Erforderliche Unterlagen	Information is provided by the respective privately run school or the respective school authority.
Voraussetzungen	<p>In principle, a child may attend a state-recognized or state-approved alternative school. All rights and obligations arising from compulsory schooling also apply without restriction to private schools. School attendance takes place in the same grade as would be attended at a state school. The operator of a private school can set and apply its own criteria for admission. There is no entitlement to admission to a private school.</p>
Kosten	<p>For attending a privately run school, parents may currently charge a maximum of €200 per month per child. In addition to this contribution, costs for lunch,</p>

Verfahrensablauf	Information is provided by the respective privately run school or the respective school authority.
Bearbeitungsdauer	Information is provided by the respective private school or the respective school authority
Frist	The School and Vocational Education Authority publishes deadlines for registration in grades 1 and 5 of state schools. These do not apply to registration at private schools. However, if no school place at a private school has been found by the deadline, a compulsory allocation of a school place at a state school can be made. It is therefore advisable to notify the responsible state school of your intention to register at a private school. Furthermore, the respective privately run school or the respective school authority will provide information on the self-imposed deadlines.

Rechtsbehelf	The decision on admission is an administrative act. You can appeal against a decision to the sending office within the deadline specified in the letter. An unsuccessful appeal will incur a fee.
Kurztext	Attendance at a private school is permitted if this school has the legal status of being recognized or approved by the state. Admission is bilateral between parents and school authorities; the authority does not arrange places at private schools
