Voraussetzungen	You are at least 18 years old when issuing the permit You have the necessary personal reliability You have the necessary physical fitness You have taken out hunting liability insurance The hunting license you have already been granted has been revoked The blocking period set by the competent authority has expired
Kosten	There is an administration fee. The amount of the fee depends on the type and scope of your application.

Verfahrensablauf	You submit your application in writing or online and provide the necessary documents. If you submit the application in writing, submit it by post or in person to the responsible office. The responsible authority will check your application for completeness and correctness and, if necessary, request any missing documents or information from you. The responsible authority will inform you in writing about the decision on your application.
Bearbeitungsdauer	Up to several weeks
Frist	The daily hunting license is valid for 14 consecutive days.
