Volltext	If the youth falconry hunting license issued to you as an annual hunting license has been revoked, you can apply for it again at the responsible authority after the specified suspension period has expired.

Erforderliche Unterlagen	if applicable, a current photograph Proof of statutory hunting liability insurance Consent of the person with custody
Voraussetzungen	You are at least 16 years old and not yet 18 years old at the time of issue You have the necessary personal reliability You have the necessary physical fitness You have taken out hunting liability insurance The hunting license you have already been granted has been revoked The blocking period set by the competent authority has expired The consent of the legal guardian is available
Kosten	There is an administration fee. The amount of the fee depends on the type and scope of your application.
Verfahrensablauf	You submit your application in writing or online and provide the necessary documents. If you submit the application in writing, submit it by post or in person to the responsible office. The responsible authority will check your application for completeness and correctness and, if necessary, request any missing documents or information from you. The responsible authority will inform you in writing about the decision on your application.
Bearbeitungsdauer	Up to several weeks
Frist	The annual hunting license for young people is valid for a maximum of two consecutive hunting years. The hunting year begins on April 1st and ends on March 31st of each calendar year.

Hinweise	With a youth falconry hunting license you are not allowed to take part in group hunts.
