If you submit the application in writing, submit it by post or in person to the responsible authority. The responsible authority will check your application for completeness and correctness and, if necessary, request any missing documents or information from you. The responsible authority will inform you in writing about the decision on your application.

Frist	The daily hunting license is valid for 14 consecutive days.
