Teaser	As the operator of a prostitution business, you must report any significant changes to the responsible authority.
Volltext	<p>If you operate a prostitution business, you must report any significant changes to the relevant authority. These include the following changes:</p> <ul style="list-style-type: none"> • Changes to the operating concept, • personnel changes affecting representation, management, operational management and supervision of the operation, • Changes to company data or data of legal representation, • Changes to the personal data of the person operating the service, • Changes to the personal data of persons subject to the reliability check, such as representation, management, supervision, etc. <p>The changes will first be examined by the responsible authority. If necessary, the responsible authority will make the appropriate changes to your permit to operate a prostitution business.</p>

Voraussetzungen	<ul style="list-style-type: none"> • You have a valid permit to operate a prostitution business • The intended changes must not be opposed by the grounds for refusal pursuant to Section 14 of the Prostitutes Protection Act (ProstSchG).
Kosten	Depends on the respective administrative fee regulations of the state or on the fee regulations of the bodies responsible under state law.
Verfahrensablauf	<ul style="list-style-type: none"> • You submit the notification of changes in the prostitution business and the relevant documents to the responsible authority. • The responsible authority checks the documents and, if necessary, carries out a reliability check. • If the examination is positive, the responsible authority will make the changes to the permit to operate a prostitution business.
Bearbeitungsdauer	If the documents are complete, the notification will be processed promptly.
Frist	You must notify us of any planned changes immediately.
