| Teaser | If you are a young person of foreign origin who wants to hunt with falcons and birds of prey in Germany and you have not passed a German falconry exam, you can apply for a foreign youth falconry hunting license under certain conditions. |
| Volltext | If you are a young foreign citizen and want to hunt with falcons and birds of prey (falconry) in Germany, you need a permit. If you do not take a German falconry and hunting exam, you can, under certain conditions, apply for an annual hunting license for young falconers of foreign origin (foreign youth falconry hunting license). The foreign youth falconry hunting license gives you permission to hunt accompanied by a guardian with hunting experience or a supervisor with hunting experience appointed in writing by your guardian(s). |

| Voraussetzungen | You are in possession of valid hunting licenses from your home country The falconry and hunter exam taken in your home country is comparable to the German falconry and hunter exam You are at least 16 years old and not yet 18 years old at the time of issue You do not have your main residence in Germany You have the necessary personal reliability You have the necessary physical fitness You have taken out hunting liability insurance You have passed a falconry exam Your legal guardians consent |
| Kosten | There is an administration fee. The amount of the fee depends on the type and scope of your application. |
| Verfahrensablauf | If you submit the application in writing, submit it by post or in person to the responsible authority. You submit your application in writing or online and provide the necessary documents. The responsible authority will check your application for completeness and correctness and, if necessary, request any missing documents or information from you. The responsible authority will inform you in writing about the decision on your application. |
| Bearbeitungsdauer | Up to several weeks |
| Frist | The annual hunting license for young people is valid for a maximum of two consecutive hunting years. The hunting year begins on April 1st and ends on March 31st of each calendar year. |

| Hinweise | With a foreign youth falconry hunting license you are not allowed to take part in group hunts. |

| Kurztext | Foreign youth falconry hunting license Apply for annual hunting license for the first time Young foreign citizens in Germany who wish to hunt with falcons and griffins (falconry) require a permit. Without a German falconry and hunting exam, an annual hunting license for young falconers of foreign origin (foreign youth falconry hunting license) is possible under certain conditions. With the foreign youth falconry hunting license, they can hunt accompanied by a guardian with hunting experience or a supervisor with hunting experience appointed in writing by the guardian. |
