Volltext	If the validity period of your foreign youth falconry hunting license issued as a day hunting license has expired or is about to expire, you must apply for an extension if you wish to continue hunting in Germany.

Voraussetzungen	You must be at least 18 years old when the permit is issued. Your main residence is not in Germany. You have the necessary personal reliability. You have the

	necessary physical fitness. You have taken out hunting liability insurance. You already have a temporary falconry hunting license for young foreign persons (foreign youth falconry hunting license), the validity of which is about to expire or has already expired. Your legal guardian or guardians consent.
Kosten	There is an administration fee. The amount of the fee depends on the type and scope of your application.
Verfahrensablauf	You submit your application in writing or online and provide the necessary documents. If you submit the application in writing, submit it by post or in person to the responsible office. The responsible authority will check your application for completeness and correctness and, if necessary, request any missing documents or information from you. The responsible authority will inform you in writing about the decision on your application.

Frist	The daily hunting license is valid for 14 consecutive days.
