Volltext	If you have been recognized as a refugee in another EU country and have a temporary residence permit to work independently in Germany, you can apply for an extension under certain conditions.

Verfahrensablauf	Find out whether the office responsible for your application allows you to submit your application online or has a special application form. In Hamburg, the application can be submitted online. You submit your application. The responsible authority will examine your application and, if necessary, request any necessary documents or information from you. The responsible office will contact you to arrange an appointment. During the appointment, your identity and documents will be checked (please bring your documents, preferably in the original, with you to the appointment). If your application is approved, your fingerprints will be taken to produce a new electronic residence permit (eAT card). You pay the applicable fees. The Federal Printing Office will be commissioned to produce your new eAT card. Once completed, you will receive information and can collect the residence permit in the form of the eAT card in person. If your application is rejected, you will receive a rejection letter. In this case, you will also have to pay an administration fee.
Bearbeitungsdauer	You should expect processing to take 6-8 weeks. If you submit all the required documents in full and well prepared, processing may be quicker. After approval, it will then take another 4-6 weeks for the Federal Printing Office to produce your electronic residence permit.
Frist	You must submit your application before your current residence permit expires (6-8 weeks in advance is recommended).
