Volltext	Building encumbrances are requirements that you, as the owner of a property, must comply with. The building encumbrance is then entered in the building encumbrance register. Under certain conditions, you can apply for the deletion of a building encumbrance from the building encumbrance register.
Erforderliche Unterlagen	The documents required vary depending on the type and scope of your application. The responsible authority can inform you accordingly.
Voraussetzungen	There is no longer any public interest in maintaining the building burden.

Verfahrensablauf	You submit an application for deletion of the building burden and provide the necessary documents. The responsible authority will examine your application and, if necessary, request any missing documents or information from you.
