| Volltext                   | If a private person, company or official institution wishes to carry out construction work on the property, there is an obligation to apply for an inspection of the property. Military explosives can remain effective almost indefinitely. In addition, security elements may have been rendered ineffective by firing or dropping them. A change of position, mechanical action or even the picking up of a warfare agent can trigger a detonation.
