Volltext	These experts from the tax offices therefore help the start-ups, for example, to fill in forms, provide them with information and advise them on general tax issues. The aim is to remove any "stumbling blocks" or "fear of contact" when dealing with the tax office and to accompany the young companies during their start-up phase, i.e. for about six months.

Verfahrensablauf	Consultation in Bremen is currently only possible in Bremen Stadtmitte. You submit the tax registration questionnaire electronically to the Bremen tax office or the Bremerhaven tax office. The questionnaire for tax registration can be downloaded from the free portal of the tax authorities "Mein Elster" at https://www.elster.de/elsterweb/infoseite/unternehmensgruendung
