Volltext	The Program for the Promotion of Applied Environmental Technologies (PFAU) supports individual and joint projects by industry and science for the development, construction and testing of innovative products, processes and services with positive effects for the environment. The funding is intended to reduce the high technical and economic risk associated with such development projects and to strengthen the competitiveness of the applicant company. 1. research and development projects Non-repayable grant of 25 - 100 % (100 % only for scientific institutions) of the eligible costs, up to a
