Volltext	In principle, you are obliged to pay maintenance to parents in need. Your ability to pay maintenance must be assessed on the basis of your individual income and burden situation. Therefore, it is necessary that you fulfill your obligation to provide information (even if forfeiture is possibly objected to).
Erforderliche Unterlagen	• Income, asset and debit documents Income, asset and debit documents please enclose a copy of the questionnaire (if possible from the last 12 months, for self-employed persons from the last three years) • Questionnaire The please fill in the questionnaire and send it back to us.
Voraussetzungen	You have received a notice of the granting of assistance (legal notice) from the service providing the benefit.
Kosten	-not if you would like to hire a lawyer yourself, the costs for this are to be borne by you
Verfahrensablauf	Please complete the questionnaire that is usually enclosed with the notification of the granting of assistance and return it to the sending office together with all supporting documents. If you wish to hand in the documents in person, please make an appointment if possible.

Bearbeitungsdauer	When your information has been completely provided, it will be processed/evaluated as soon as possible. However, since further information may also be required from siblings, for example, a concrete period cannot be given as a lump sum.
