Teaser	<p>You may be entitled to basic social security under Social Security Code XII:</p> <ul style="list-style-type: none"> • when you reach retirement age (staggered by years of birth) or older, or • if you are permanently disabled for work, and • your income and assets or those of your spouse or partner are not sufficient to cover your living expenses.
Volltext	<p>Basic provision in old age and in the event of a permanent reduction in earning capacity is granted to ensure the necessary subsistence if one's own income and assets or those of one's spouse or partner are not sufficient. Since January 1, 2005, basic income support has been a form of social assistance (assistance for subsistence).</p> <p>In contrast to other social assistance benefits, no maintenance is demanded from dependent children or parents if their annual income is below 100,000 euros. The benefits are essentially the same as subsistence assistance.</p> <p>The basic provision includes</p> <ul style="list-style-type: none"> • the applicable standard rate of social assistance • the reasonable actual costs of accommodation and heating • Additional requirements in the case of possession of a severely disabled person's card with the characteristic G and in the case of illness, if a costly diet is required • Contributions to health and long-term care insurance <p>Basic income support is also provided in the case of inpatient accommodation, for example in a nursing</p>

Verfahrensablauf	<p>The application may be made in writing, by telephone or even in person without observing any form. The necessary application documents must then be submitted in full and in a timely manner.</p> <p>The Social Office provides an application form for the application of benefits according to Social Code Book XII. It is usually filled out by the clerk together with the applicant.</p>
Bearbeitungsdauer	The prerequisite for rapid processing is the complete application
Frist	Benefits are granted from the 1st of the month in which the application is submitted.
