Vehicles that were first registered for traffic at least 30 years ago are considered "historic". The date of the first registration is decisive. These vehicles must primarily serve the preservation of motor vehicle cultural assets. In the license plate, historic vehicles have an "H" ("H license plate") in the last position.

**Erforderliche Unterlagen**

- Identity card or passport
- if registered to companies additionally: - Current and valid business registration and, if available, current and valid excerpt from the commercial register (also as a copy) - Power of attorney, if the person authorized to dispose does not personally submit the application on site
- in case of representation with written power of attorney additionally: identity card or passport of the authorised representative
- Registration certificate part I (formerly: vehicle registration document)
- Registration certificate part II (formerly: vehicle registration document) If the ZB II is in the possession of a third party, it must be sent to the licensing authority. Only when the document is available to the authority can the change be made. After completion, the document is returned to the sender.
- License plates for registered vehicles
- electronic insurance confirmation (eVB)
- Direct debit authorisation for motor vehicle tax (SEPA Direct Debit Mandate)
- if necessary, confirmation of reservation for the desired license plate
- for vehicles withdrawn from service before 1 October 2005: certificate of immobilisation instead of vehicle registration document
- Vehicles for which no type approval is available

additionally: - full expert opinion according to § 21 StVZO

- valid identity card or passport
- external licence plates in the case of registered vehicles which are not registered in Bremen or Bremerhaven at the time of their registration there
- for registered vehicles additionally: - registration certificate part I (vehicle registration document) - registration certificate part II (vehicle registration document) - if applicable the previously assigned registration plates - expert opinion § 23 StVZO (expert opinion for the classification of a vehicle as a classic car) and general inspection

## Voraussetzungen

- first registered at least 30 years ago
- appraisal by an officially recognized expert from a technical inspection agency or a test engineer from an officially recognized inspection organization
- as far as possible in original condition and good state of preservation of the vehicle
- no outstanding fees and expenses from previous registration processes. In the case of payment arrears, the registration authority may not register the vehicle until these have been settled.
- No motor vehicle tax arrears (including ancillary tax payments, e.g. interest, late fees). Motor vehicle tax accounts are verified by the registration authority as part of the processing of the registration application. In the event of tax arrears, the registration authority may not register the vehicle until these have been settled.
- Written direct debit authorization for the collection of vehicle tax.

Important: This is a service under municipal jurisdiction. Therefore, you can only go to a service that is located in your place of residence.

Increase possible for specific occasions (issue of new vehicle documents, optional license plates, etc.)

## Verfahrensablauf

- An application for registration must be submitted to the registration authority. The application can also be submitted by a representative (e.g. car dealer) with a written power of attorney. In the case of

representation, a copy of the identity card of the person granting the power of attorney is sufficient.

- If a preferred license plate is desired, reservation can be made in person, in writing or by telephone, and as an online service via the Internet, even before the new registration.
- The insurance company is automatically informed by the registration authority about the allocation of the license plate.
- Registration of a company: If the correct name of the company and also the names of the persons responsible can be seen from the business registration, the business registration is sufficient, otherwise the extract from the commercial register is also required.

To avoid longer waiting times, appointments can be made: -> for Bremerhaven: by telephone at (0471) 590-3470 or 3480.

Note: Customers without an appointment will be served in parallel, with priority given to customers with an appointment. Commercial registration requests will continue to be accepted without an appointment.

Tip: License plates can be made during the registration process. Private vendors have located near the registration offices to do this. The cost of the plates is not included in the fees. The license plates are stamped by the registration authority, i.e. provided with stickers for the general inspection and the registration district.

## Hinweise

- An amendment to the Vehicle Tax Act came into force on July 1, 2010. The following changes apply to registrations as of July 1, 2010: - When registering a vehicle, a SEPA direct debit mandate is required for the collection of the vehicle tax. A SEPA direct debit

mandate issued for the first taxation is also valid for subsequent years.

- Vehicles with this license plate are tax-exempt and subject to a flat-rate motor vehicle tax of 46.02 euros for motorcycles or 191.73 euros for all other vehicles.
- Motor vehicle tax exemption or reduction due to severe disability: Severely disabled people with the mark "H", "BI" or "aG" in their severely disabled ID card continue to be exempt from motor vehicle tax. Based on the proof in their ID card, they do not have to submit a direct debit authorization. Further information is available from the main customs office in Bremen.
- Electronic confirmation of insurance (eVB): You can obtain the confirmation of insurance regarding the motor vehicle liability insurance from the insurance company of your choice. In most cases, you can request the insurance confirmation from your insurance company by telephone. Since March 1, 2008, the insurer can give you an insurance confirmation with a 7-digit alphanumeric VB number, which the registration authority uses to retrieve the insurance data electronically from the central database of the German Insurance Association.
