Teaser	<p>If you are living in Bremen with the status of toleration and it is impossible for you to leave Germany for a longer period of time for reasons that are not your fault, you can apply for a residence permit at the Migration Office. This also applies if you have been living tolerated in Bremen for several years and you have integrated well / sustainably. You can find out more about the requirements here:</p>
Volltext	<p>If you are living in Bremen with the status of Duldung and it is impossible for you to leave Germany for a longer period of time for reasons that are not your fault, you can apply for a residence permit at the Migration Office.</p> <p>Such reasons can be, for example</p> <ul style="list-style-type: none"> <li>• that a safe return to your home country is not possible for you,</li> <li>• that you are so seriously ill for a longer period of time that you are not able to travel,</li> <li>• that you are responsible for the care of a child in Bremen or are needed to care for a close relative.</li> <li>• A residence permit for humanitarian reasons can also be considered, for example, if you are <ul style="list-style-type: none"> <li>• are a young person or under 21 years of age and</li> <li>• have been living in Germany for at least 4 years and are successfully attending school or training.</li> <li>• Or if you have lived in Germany for at least eight years or, if you live together with a minor child, for at least six years and have integrated yourself sustainably in Germany.</li> </ul> </li> </ul> <p>Further requirements are that there is no doubt about your identity, that you are free from criminal prosecution and that, if you are an adult, you are able to secure your own livelihood if possible or make demonstrable efforts to do so, unless this should be impossible for you due to raising children or illness.</p>
Erforderliche Unterlagen	No documents required.

Voraussetzungen	No special requirements.
Kosten	We will inform you about the costs when we check whether you are eligible for a residence permit.
Verfahrensablauf	<p>If you assume that you meet the requirements for the issuance of a residence permit, you can apply for it at the Migration Office. E.g. at your next appointment for the extension of your Duldung. You can also send us a written request by e-mail to <a href="mailto:ref30@migrationsamt.bremen.de">mailto:ref30@migrationsamt.bremen.de</a>.</p> <p>The employees of the Migration Office will also check on their own initiative whether the conditions for issuing a residence permit are met and will raise the issue when extending your toleration permit, if this should be the case in our opinion.</p>

Frist	The application is not bound to any deadlines. If the requirements for issuance are met, the residence permit can be issued immediately.
