Teaser	If your work involves contact with open food (for example, making or working with food), you will need a certificate from the health department before you begin working in the food area for the first time.
Volltext	<p>Any person who commercially produces, handles, sells or otherwise markets foodstuffs or comes into contact with foodstuffs requires a certificate from the public health department in accordance with Section 43 of the Infection Protection Act.</p> <p>In the case of trainees, a decision is made on a case-by-case basis (by the health office).</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Identity card or passport • Cost absorption certificate Health certificate <p>A decision by the job centre or an application for reimbursement from an authority is not sufficient in this case. The certificate of cost absorption must be addressed to the health office and must include the billing address and signature.</p>
Voraussetzungen	Persons with insufficient knowledge of German (reading and speaking) need a person to assist with translation.
Kosten	<p>Gebühr: 34€</p> <p>This amount is to be transferred to the account of the public health department. Please bring the transfer receipt to your appointment. If the employer or an institution covers the costs, the health office must have or present a cost transfer slip.</p> <p>Gebühr: 15€</p> <p>Fees for a duplicate that can be issued in case of loss of the original certificate. The retention period for the data proving the possible issue of a duplicate of the certificate is 10 years.</p>

Verfahrensablauf	After prior registration by e-mail to belehrung.gesundheitsamt@magistrat.bremerhaven.de or by telephone on 0471 590-2351, the instruction will take place at the health office. This will be handed out after the instruction.
Bearbeitungsdauer	Duration of the appointment: approx. 1.5 hours
Frist	The activity must be started within the first 3 months after receipt of the health certificate/instruction. Then the health certificate is valid for life. An interruption of the activity does not cancel the lifelong validity.

Hinweise	<p>The certificate replaces the former health certificates (§§ 17, 18 Federal Epidemics Act). The old certificates (from 1980) remain valid.</p> <p>Instruction sessions take place on Tuesday and Thursday at 08:00.</p> <p>Further information can be found on the homepage of the public health department.</p>
