Volltext	In order to hold a street party on public ground in the open air and in tents, you need a permit according to §18 Bremisches Landesstraßengesetz. We would like to point out that holding a street party without the required permit, but also a violation of the conditions listed in the permit, is an administrative offense. This can be punished with a fine.
Erforderliche Unterlagen	No documents required.
Voraussetzungen	No special requirements.
Kosten	no fees are payable Possible costs for shut-off measures
Verfahrensablauf	For a street festival permit, please submit a written application with the following information: • Event location (outdoor or tent) • Event period • Event activities (planned music program and possibly other event contributions such as play activities, set-up of stages and booths) • Food and beverages (cost price or commercial sale) Please note that if you are selling alcoholic beverages on a commercial basis for consumption on site, you will need a permit in accordance with the German Restaurant Act (Gaststättengesetz).
