Voraussetzungen	• Applicant is the owner of a public pharmacy • Dispatch may only be made from a public pharmacy, in addition to the usual • pharmacy operation • The legal requirements for pharmacy operations apply • A quality assurance system for the shipping operation must be in place

Kosten	Please note that there is a fee for issuance of the permit pursuant to Section 500.03 of the current Bremen Health Care Cost Ordinance.
Verfahrensablauf	- You submit your written application for a mail order permit and all required documents to the competent authority. - The authority may request additional documents. - The mail order permit is to be issued when the competent authority determines that the legal requirements have been met.
Bearbeitungsdauer	4 Woche(n)
Frist	4 Woche(n) The application should be submitted at least 4 weeks before the pharmacy plans to begin mail order operations.

Hinweise	- All drug retailers operating a web store must be entered in a central register at the Federal Institute for Drugs and Medical Devices (BfArM). - The BfArM maintains a mail-order pharmacy register in which all German pharmacies with a mail-order authorization are listed. The BfArM issues a safety logo to these retailers, which the providers can also display on their homepage.
