Teaser	Do you receive advance maintenance payments and there have been changes? Report them immediately.
Volltext	You must notify the Maintenance Advance Office of any important changes during the entire period of benefit receipt. You must report all changes that may be important for the claim or about which you have made declarations in connection with the maintenance advance. You must report the changes within 14 days at the latest. Examples of changes: • Your child no longer lives with you • You move house. • You get married. • You move in with the other parent. • The other parent pays maintenance again or wants to pay maintenance again. • You become aware of the previously unknown whereabouts of the other parent. • The other parent has died. • The child has died. • The child no longer attends school. • The income of the child who no longer attends school changes (because, for example, the amount of the training allowance changes) Notifications to other authorities are not sufficient.

Modul	Sachverhalt
	An intentional or negligent breach of these obligations is an administrative offense and can be prosecuted or punished with a fine. In addition, the benefits paid can be reclaimed.
Erforderliche Unterlagen	
Voraussetzungen	• You receive advance maintenance payments. • There have been important changes.
Kosten	There are no costs involved.
Verfahrensablauf	If you have any changes, you can inform the Maintenance Advance Office online or in writing.
Bearbeitungsdauer	
Frist	You must specify the changes no later than 14 days.
