Teaser	Would you like to apply for recognition of your foreign qualification as an elementary educator or childhood educator? Then contact the Senatorial Authority for Children and Education - Department 31 - for a consultation.
Volltext	The profession of early childhood educator is regulated in Germany. This means that you must have a specific qualification in order to work in the profession. If you have a foreign professional qualification as an elementary pedagogue or childhood educator, you can work in this profession in your chosen federal state under certain conditions. profession in the chosen federal state. To do this, you must submit an application with all the necessary

documents to the Senatorial Authority for Children and Education - Department 31.

In the recognition procedure, the office compares your professional qualification from abroad with the professional qualification in the selected federal state and issues an equivalence assessment. You will receive feedback after your application has been reviewed. If your professional qualification is equivalent and you meet the other requirements, you will receive state recognition. You may then use the professional title "state-recognized elementary teacher" or "state-recognized elementary teacher".

If you do not have the professional qualifications required for recognition, the essential differences will be listed in the notification. You can then take a compensatory measure.

Please note that in the federal state of Bremen, equivalence is only possible with the qualification "state-recognized elementary teacher" or "state-recognized elementary teacher".

Erforderliche Unterlagen

- Documents required for recognition as an elementary teacher
 - Application form
 - Curriculum vitae
 - Proof of identity (identity card or passport)
 - Proof of your professional qualification
 - Proof of training
 - Proof of professional experience as an elementary school teacher
 - Proof of other qualifications
 - Certificate that the profession may be practiced in the country of training
 - Information on applications for recognition that have already been submitted. Then state the body to which you have submitted the application.

You usually submit these documents later. The competent authority will inform you when you should submit the documents:

- Proof of your personal suitability: for example,

	criminal record extract or certificate of good conduct • Proof of your German language skills: Language certificate C1 If your documents are not in German, you must submit German translations of your documents. The translations must be made by translators who are publicly appointed or authorized.
Voraussetzungen	• Equivalence of your professional qualification • You must be authorized to practice the profession in the country in which you trained. You must also meet the other requirements for state recognition. These are usually • Personal suitability: you are reliable to work as a childhood educator and have no criminal record. • Health suitability: You are mentally and physically able to work in the profession. • You have German language skills at the required language level C1.

Verfahrensablauf	You can submit the application to the competent state authority. You must submit all the necessary documents in the form of copies to the competent authority. The competent authority will then check: Is your professional qualification equivalent to the professional qualification in your federal state? For example, the content of the training and the duration of the training are important for the comparison. The competent body will also take into account your professional experience, other certificates of competence and qualifications. The competent body then checks the other requirements. If your professional qualification is equivalent and you meet all other requirements, you will receive state recognition. You may then use the

	professional title "state-recognized childhood educator" or "state-recognized childhood educator". If the competent authority is unable to determine equivalence, you will receive a notification with an explanation of the significant differences. In order to compensate for significant differences, you can take a compensation measure. If you successfully complete the compensation measure and meet the other requirements, you will receive state recognition.

State recognition must be revoked if the reason for refusal arises subsequently. State recognition must be withdrawn if it subsequently becomes known that the requirements for granting it were not met.
