Volltext	If you wish to provide extrajudicial legal services against payment, you must be registered in the Legal Services Register. Registration is possible for: • Debt collection services. The debt collection sector collects third-party receivables or receivables assigned for collection purposes, thereby helping to improve the liquidity of its clients. • Pension advice in the field of statutory pension and accident insurance social compensation law other social security and disability law relating to a statutory pension and occupational and occupational pension law. • Legal services in a foreign law. If you wish to change your entry in the legal services register, you must submit an application to the competent office.

	No. 1110 Registration under the RDG: If a legal entity or a company without legal personality is registered, the fee also covers the entry of a qualified person in the legal services register. The fees for matters under the Legal Services Act (RDG) are determined in accordance with Section 1 (2) No. 3 of the Administration of Justice Costs Act (Justizverwaltungskostengesetz)
Verfahrensablauf	You apply for the change at the responsible office. The competent office will check whether all the necessary documents have been submitted. If the check is positive, the change will be made in the legal services register.
Bearbeitungsdauer	Once you have submitted the application for a change, the responsible office will process it promptly.
