Teaser	If you, as a hunting association, have a firearms possession card (WBK) and wish to purchase a firearm requiring a permit, you must apply for this.
Volltext	If you, as a hunting association, have a gun ownership card (WBK) and wish to purchase a firearm requiring a permit, you must apply for this. The permit is issued by the competent authority by means of an entry in the gun ownership card (pre-entry). With the pre-entry, you have one year to acquire the registered firearm. In the application for a permit to purchase a firearm, you only need to state what type of firearm and caliber you wish to purchase. Further details, such as the manufacturer and exact model, are not initially required. You only have to provide this information once you have acquired the weapon and have fulfilled your obligation to notify the competent authority of the acquisition of the weapon. The gun dealer must also report the transfer of the weapon to you.

	You must prove that you can safely store the weapon you wish to purchase.
Erforderliche Unterlagen	• Identity card or passport (copy)
Voraussetzungen	You have a gun ownership card (WBK) for clubs.
Kosten	The fees may vary and depend on various factors. Further information on fees can be found in the Internal Administration Costs Ordinance. You will find the link under "Legal bases" - "Cost Ordinance for Internal Administration (InKostV)".
Verfahrensablauf	You must apply for pre-registration with the competent firearms authority. Submit the application together with the required documents. Application in paper form • You can request a print-out of the application form by e-mail at waffenundjagd@ordnungsamt.bremen.de or you can obtain a paper copy from the competent authority on site. • Complete the application. • Attach a copy of the required documents to the application. • Send everything by post or hand in the documents on site after making an appointment. The completed application should be handed in to the responsible office. • You will receive the decision by post.
