The so-called wastewater fee will no longer exist in future</p> <p>The drainage fee is made up of 2 parts for all properties:</p> <ol style="list-style-type: none"> <li>1. The discharge and treatment of wastewater.</li> <li>2. In order to determine the sealed areas, aerial photographs are first taken and evaluated. This is expected to take until mid-2025.</li> <li>• Property owners or other authorized parties are expected to receive survey forms with an overview graphic of the built-up areas of the property from 2025.</li> <li>• Check the calculation basis using some of the questions contained in the survey form. The survey form also includes an auxiliary form for completion. Consultation options will also be set up to provide assistance as soon as the survey forms are sent out. Contact details will be provided together with the survey forms.</li> <li>• Please return the completed survey form.</li> <li>• The complete changeover should be completed by the end of 2026.</li> <li>• You will then receive notification of the rainwater fees from hanseWasser Bremen GmbH by 2027 at the latest, in which the fee from 01.04.2024 to the current billing period will then be billed.
